The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act and other Florida Statutes, do hereby adopt the following articles of incorporation:

ARTICLE ONE

Name

The name of the corporation is Tony's Quick Stop, Inc.

**ARTICLE TWO
CORPORATE DURATION**

The duration of the corporation is perpetual. The corporate existence is to commence at the time of filing of the articles of incorporation by the Department of State.

**ARTICLE THREE
PURPOSE**

The general purposes for which the corporation is organized are:

1. To engage in the business of selling of food, drink, and other items to the general public.
2. To operate a convenience store and other businesses.
3. To transact any other lawful business for which corporations may be incorporated under Florida Law.
4. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

**ARTICLE FOUR
CAPITALIZATION**
