ARTICLES OF INCORPORATION

WE, GERARD TOBIA, CONSTANCE TOBIA, DANIEL FOWLIE and DENTSE FOWLIE, the undersigned, do hereby make, subscribe, acknowledge and file with the Secretary of the State of Florida, these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I - NAME
