The undersigned incorporator for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be DAYTIME OF CENTRAL FLORIDA, INC. and it shall hereinafter be referred to as "Corporation".
