The undersigned subscribers to these Articles of Incorporation, both natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is NWK FOOD & GAS, INC.

ARTICLE II - NATURE OF BUSINESS

ARTICLE V - INITIAL BOARD OF DIRECTORS



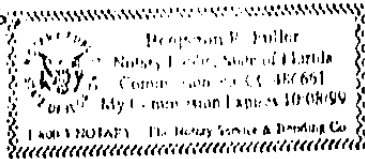
