Today we received your letters dated October 31, 2001, regarding the above listed clients, we pray to have these corporations reinstated in behalf of our clients for the following reason

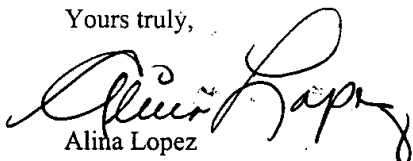
