**ARTICLE I - NAME**

The name of this Corporation is INVERTEL, INC. and its address is c/o RJS, 201 S. Biscayne Boulevard, 1600 Miami Center, Miami, FL 33131.

**ARTICLE II - DURATION**

This Corporation shall have perpetual existence.

**ARTICLE III - PURPOSE**

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE IV - CAPITAL STOCK**

This Corporation is authorized to issue 10,000 shares of ten (\$.10) cent par value common stock, which shall be designated "Common Shares."
