Pursuant to the provisions of Section 607.1006, Florida Statutes, PYHSICIANS' ACCOUNTING & CONSULTING, INC., a Florida for profit corporation (the "Corporation"), adopts the following articles of amendment to its articles of incorporation which were filed with the Florida Department of State on May 9, 1996, Charter Number P96000040146:

FIRST: Article I of the Articles of Incorporation of this Corporation is amended to read in its entirety as follows:

Article I
Corporation Name

The name of the corporation shall be: **GSM Equities, Inc.**
