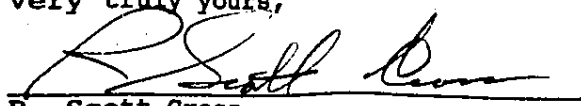

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I
Name

The name of the corporation is CROSS & ROBBINS, P.A.

ARTICLE II
Business

The corporation's sole business is the rendering of professional legal services to the general public.

ARTICLE III
Stock

The total number of shares of stock which the corporation will have authority to issue is One Thousand (1,000) shares of One Dollar (\$1.00) per share par value common stock. All of said stock will be payable in cash or real or personal property or such consideration as may be fixed by the shareholders.

ARTICLE IV
Registered Office and Agent

The initial address of the principal and registered office of the corporation is 6696 S.W. 17th Terrace Road, Ocala, Florida 34476.

ARTICLE V
Management of Corporation by Shareholders

Preemptive Rights

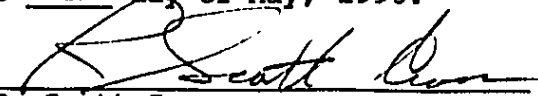
Every shareholder, upon the sale for cash of any new stock

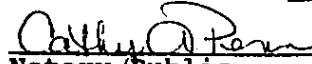

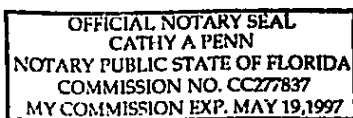

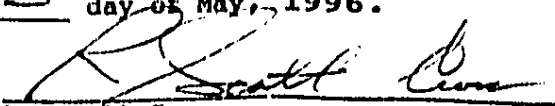
