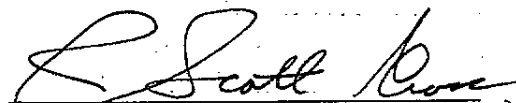

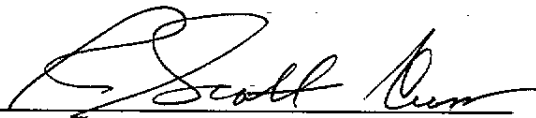
1. The name of the corporation currently is CROSS & ROBBINS, P.A..
