The undersigned, desiring to form a Corporation pursuant to Section 607, et seq., Florida Statutes (1991), hereby adopt the following Articles:

ARTICLE I. - NAME

The name of the Corporation shall be NORTHWEST STEAL, INC..

ARTICLE II. - ADDRESS OF CORPORATE BUSINESS OFFICE
