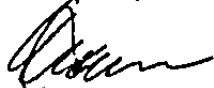

ARTICLES OF INCORPORATION

OF

AAAEMS ACCREDITED AIR AMBULANCE EMERGENCY MEDICAL SERVICES
AND WORLDWIDE MEDICAL TRANSPORTS, INC.

I.

NAME

The name of this corporation shall be AAAEMS Accredited Air Ambulance Emergency Medical Services And Worldwide Medical Transports, Inc.

II.

PURPOSE

This corporation is organized to engage in any activity of business permitted under the laws of the United States or of this State.

III.

TERM OF EXISTENCE

This corporation shall begin existence as of the date of filing and shall exist perpetually.

IV.

CAPITAL STOCK

This corporation is authorized to issue seven thousand five hundred (7,500) shares of \$1.00 par value.

V.

PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

INITIAL PRINCIPAL OFFICE, REGISTERED OFFICE AND AGENT

INDEMNIFICATION

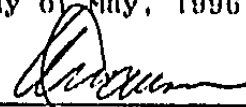
The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

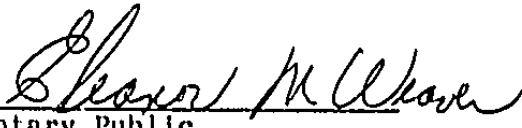

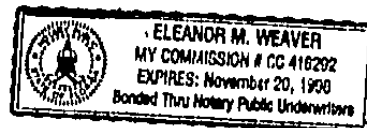
