The undersigned, a natural person competent to contract, hereby subscribes to these Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is Mark J. Leeds, P.A.

NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:
