ARTICLE I - NAME

The name of this corporation is RELIABLE TRANS., INC. The principal address of this corporation is 2214 WILEY COURT, HOLLYWOOD, FLORIDA 33020.



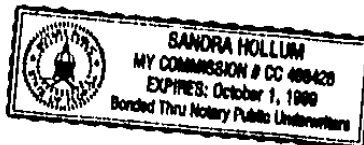
