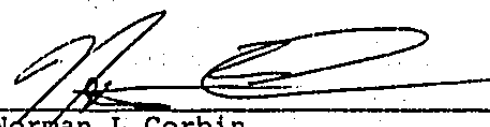

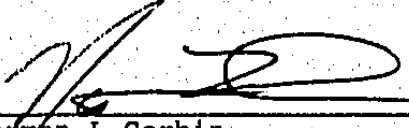

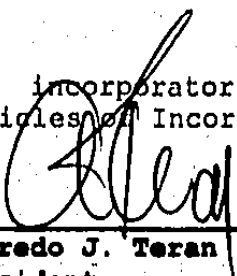

The remainder of Article III remains unchanged.

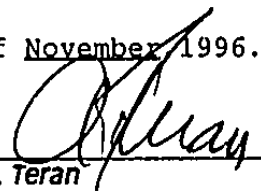
