ARTICLES OF INCORPORATION

The undersigned, acting hereby as Incorporator for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit, pursuant to Chapter 607, Florida Statutes, and other applica! 'e law, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be TED MEADE & SONS CONSTRUCTION, INC.

ARTICLE II ADDRESS AND REGISTERED OFFICE
