

ARTICLE I - Name and Address

The name of this corporation is SEVENTH INNING STRETCH, INC. The mailing address of the corporation is: 111 Second Avenue NE, St. Petersburg, Florida 33701. The address of the corporation's principal office is 111 Second Avenue NE, St. Petersburg, FL 33701.

ARTICLE II - Duration

This corporation shall have perpetual existence.

ARTICLE III - Capital Stock
