ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED sole incorporation, being a natural person competent to contract and desiring to form a corporation under Title XXXV, Chapter 607 of the revised Florida Statutes, herewith submits the following information:

1. The name of the corporation is Pro-Kote Industries, Inc.
