

#### ARTICLE OF INCORPORATION

OF

### KINGDOM DEVELOPERS GROUP, INC.

T, THE UNDERSIGNED, hereby establish myself for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

#### ARTICLE I

The name of the corporation shall be:

# ARTICLE II - PURPOSE
