ARTICLE TWO

THIS CORPORATION IS TO PROVIDE HAIR CARE OF ALL KINDS AND BEAUTY SUPPLIES WHEREAS WE WILL OPERATE THE BUSINESS SEVEN (7) DAYS PER WEEK, TWELVE (12) MONTHS PER YEAR.
