ARTICLES OF INCORPORATION OF  
FLORIDA WEB SERVICES CORP.

ARTICLE I.  
CORPORATE NAME

The name of this corporation shall be: Florida Web Services Corp.

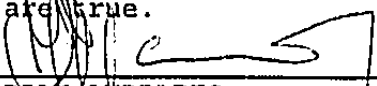

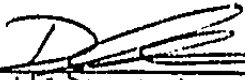
