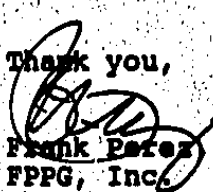

OF

ARTICLE I

The name of this Corporation is: FPPG, Inc.

ARTICLE X

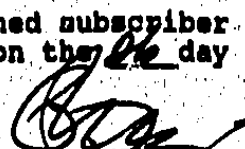

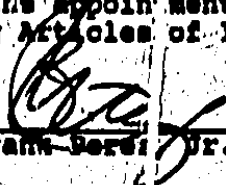
