The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is CUSTOM QUALITY MANUFACTURING, INC.

ARTICLE II - DURATION

The period of its duration is perpetual, commencing on the date of July 8, 1996.

ARTICLE III - PURPOSES

The general purposes for which this corporation is organized are to transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act and to do such other things as are incidental to the foregoing or necessary of desirable in order to accomplish the foregoing.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which the corporation shall have authority of issue is Three Hundred (300) of the par value of \$10.00 each.

ARTICLE V - PREEMPTIVE RIGHTS

The corporation will not commence business until it has received for the issuance of shares consideration of the value of \$3,000 consisting of money, labor done or property actually received.
