The undersigned, acting as Incorporator of a corporation under the Florida Business Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I--NAME**

The name of this corporation is J & M Bloodworth, Inc. and the principal office is located at HC3, Box 52, Old Town, Florida 32680.

**ARTICLE II--DURATION**

The period of its duration is perpetual.

**ARTICLE III--PURPOSE**

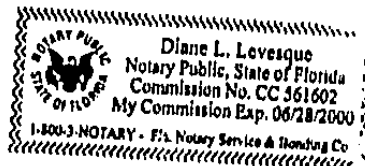
