ARTICLES OF INCORPORATION OF FIFTH AVENUE T.V. PRODUCTIONS, INC.

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE 1 - Name

The name of the corporation is **FIFTH AVENUE T.V. PRODUCTIONS, INC.** The principal place of business of the corporation is 505 Fifth Avenue South, Naples, Florida 34102. The mailing address of the corporation is 505 Fifth Avenue South, Naples, Florida 34102.

ARTICLE II - Commencement and Duration

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III - Purpose
