Name

The name of the Corporation shall be: Turuco, Inc.

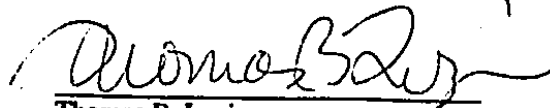
