"LLAMISSLE, FLOSSE The undersigned, acting as incorporator of a corporation to be formed under the provisions of the laws of the State of Florida, hereby adopt the following Articles of Incorporation for such corporation, to be filed with the Secretary of State of the State of Florida:

ARTICLE 1

The name of the corporation shall be PRIME MEDICAL PHARMACY, INC. The principal place of business of this corporation shall be 3400 Coral Way, Suite # 101, Miami, Florida 33145.

ARTICLE II

The Corporation shall have perpetual existence commencing at the filing of the Articles of Incorporation with Department of State.

ARTICLE III

The general nature of the business to be carried out by the Corporation is as follows:
