ARTICLES OF INCORPORATION
OF

The undersigned subscribers to the Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be DATA RECOVERY LABS, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence, commencing no later than as of the date of acceptance and filing of these Articles by the Secretary of the State of Florida, and shall exist upon the date of the execution of these Articles if permitted by law. The Address of the principal Corporate Office shall be 24705 U.S. Highway 19 N., #312, Clearwater, FL 34623.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares that the Corporation is authorized to issue is one-hundred (100) shares, which shall have a par value of \$1.00. Such shares shall be fully paid and nonassessable. All capital stock shall be paid for in U.S. currency, or in property, labor or services at a fair valuation to be fixed by the directors. Every shareholder upon the sale for cash or exchange for property of any new stock of this Corporation, of whatever kind or class, shall have the right to purchase his pro rata share thereof at the price at which it is offered to others.

ARTICLE VI - REGISTERED ADDRESS AND REGISTERED AGENT

The address of the registered office of this corporation in the State of Florida is: 24705 U.S. Highway 19 N., Suite #312, Clearwater, Florida, 34623, and the registered agent is ADAM D. SHARP.

ARTICLE V - INCORPORATORS AND SUBSCRIBERS

ARTICLE VI - PURPOSE

This Corporation is organized for the purpose of engaging in any activity or business allowed under the laws of the State of Florida and the laws of the United States; and, without limiting the foregoing: to own, operate, and manage computer repair and maintenance operations, recovery of lost and damaged media, conduct marketing, wholesale, and retail operations, to engage in consulting, training, management and investments; to buy and sell real estate; acquire and deal in property, business rights licenses or franchises; and to do any other things and to exercise any and all powers which a natural person could do or exercise and which are now or hereafter authorized by law.

ARTICLE VII - INDEMNIFICATION

The Corporation shall indemnify any officer or shareholder acting in such capacity, or any former like-situated person, to the full extent permitted by law.

ARTICLE VII - OPERATIONS AND CONTROL

Unless changed by the By-laws, the business of this Corporation shall be managed by its Directors in accordance with the By-Laws. The By-Laws may provide for the election or appointment of officers by the Directors or by the shareholders.

ARTICLE IX - BY-LAWS

The initial By-Laws shall be adopted by majority approval of all Directors. The power to alter, amend or repeal the By-Laws or to adopt new By-Laws is vested in the Shareholders, and exercisable upon the vote of the majority of all shares outstanding or in accordance with the By-Laws or any written agreements between and among the shareholders.

ARTICLE XI - AMENDMENTS

These Articles of Incorporation may be amended as provided by law, subject to the By-

Laws and any agreements of the incorporators or shareholders.

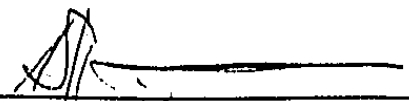
