ARTICLES OF INCORPORATION

OF

SHERIDAN ENTERPRISES, INC.

The undersigned, acting as incorporator of a Corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I

NAME

The name of this Corporation is **SHERIDAN ENTERPRISES, INC.**

ARTICLE II

DURATION

This Corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III

PURPOSE

The general purposes for which this Corporation is organized are the following:

A. To engage in and transact any lawful business for which a corporation may be incorporated under the Florida Business Corporation Act. No other purpose limits this general purposes in any way.

B. To do such other things as are incidental to the purposes of this Corporation, or necessary or desirable in order to accomplish them.

ARTICLE IV

CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is **FOUR THOUSAND (4,000)** shares of Common Stock, having a par value of **ONE HUNDRED (\$100.00)** dollars per share. All said shares shall be payable in cash, property, labor, or services at a valuation to be fixed by the Board of Directors.

ARTICLE VI

DIRECTORS

The number of Directors constituting the initial Board of Directors is **One**
(1). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one (1).

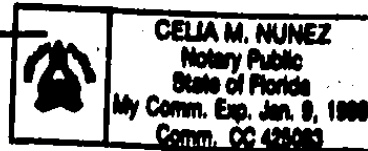
