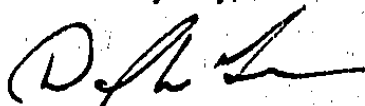

The name of the corporation is AAA Truss, Inc.

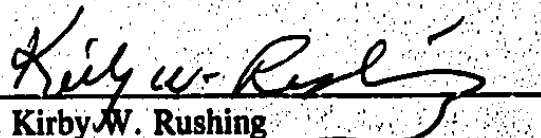
ARTICLE VIII - PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE IX - RESTRICTIONS ON TRANSFER OF STOCK

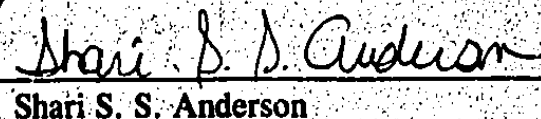
