

Pursuant to the requirements of Sections 607.1003 and 607.1006, Florida Statutes, the undersigned does hereby make, swear to, adopt and file this Certificate of Amendment to the Articles of Incorporation of COTELLIGENT/JASTECH CORPORATION (the "Corporation"), which Corporation was incorporated under the laws of the State of Florida on September 25, 1996, under Charter No. P96000079582:

1. The sole member of the Board of Directors of the Corporation has recommended a proposed corporate name change to the sole shareholder of the Corporation, and the sole shareholder of the Corporation has unanimously voted to change the Corporation's corporate name from COTELLIGENT/JASTECH CORPORATION to JASTECH, INC. Therefore, Article I of the Corporation's Articles of Incorporation shall be deleted in its entirety and the following inserted in its place:

ARTICLE I

Name and Duration

"The name of the Corporation shall be JASTECH, INC. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State."

- 2. All other provisions of the Corporation's Articles of Incorporation shall remain in full force and effect, unaltered except as expressly provided above.
