ARTICLES OF INCORPORATION OF

The Undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is ACCURATE CABINETS, INC.

<u>ARTICLE II - TERM OF EXISTENCE</u>

The period of duration of the corporation is perpetual.
