# ARTICLES OF INCORPORATION OF

The undersigned incorporator, who is a duly licensed attorney in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 and Chapter 621 of the Florida Statutes, hereby presents these Articles of Incorporation to the Secretary of State of the State of Florida.

# ARTICLE I
