The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I. Name. The name of the Corporation shall be:

DELTA DURABLES, INC. ("Corporation").

Article II. Principal Office. The initial principal place of business and mailing address of this Corporation shall be: 125 West Romana Street, Suite 400, Pensacola, Florida 32501.

Article III. Capital Stock. The aggregate number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is Seven Thousand Five Hundred (7,500) shares of common stock, having a par value of \$1.00 per share. The Seven Thousand Five Hundred (7,500) shares of common stock of the Corporation shall be composed of Two Thousand Seven Hundred (2,700) shares of such common stock being **non-voting common stock** and Four Thousand Eight Hundred (4,800) shares of such common stock being **voting common stock**; provided however, that all shares of common stock of this Corporation (both voting common stock and non-voting common stock) shall confer identical rights to distribution and liquidation proceeds.

Article IV. Address of Registered Office and Name of Registered Agent. The street address of the initial registered office of this Corporation in the State of Florida is 125 West Romana Street, Suite 400, Pensacola, Florida 32501, and the name of the initial registered agent of the Corporation at that address shall be Scott J. Bell.
