The name and address of the person signing these Articles is John D. Ufheil whose address is 9410 Live Oak Place, #111, Ft Lauderdale, 33324.


ARTICLE VIII - INDEMNIFICATION



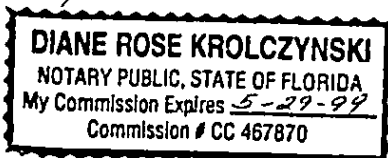


