

The undersigned incorporators subscribing to these Articles of Incorporation, a Professional Association duly licensed to render services as such, under the laws of the State of Florida, hereby presents these Articles of Incorporation for the formation of a corporation under the laws of the State of Florida pursuant to "The Professional Service Corporation Act", of 1987.

ARTICLE 1 - NAME AND PRINCIPAL ADDRESS

The name of this corporation is ALAVI & BIRD, P.A. The principal office is located in Ocala, Florida. The address of the principal office is 11 N. Magnolia Avenue, Suite C, Ocala, Florida 34475. The mailing address is the same. The principal address and mailing address are the same.

ARTICLE 2 - PURPOSE

The general nature of the business to be transacted by this corporation is to engage in every phase and aspect of the business of rendering the same professional services that a law firm duly licensed under the laws of the State of Florida is authorized to render and to engage in any activity permitted under the laws of the State of Florida and the United States.

ARTICLE 3 - CAPITAL STOCK

This Corporation is authorized to issue 100 shares of common stock having a par value of \$1.00.

No contract or other transaction between this corporation and any other corporation shall be affected by the fact that any director of this corporation is interested in, or is a director or officer of, such other corporation, and any director, individually or jointly, may be party to, or may be interested in, any contract or transaction of this corporation or in which this corporation is interested; and no contract, or other transaction of this corporation with any person, firm or corporation, shall be affected by the fact that any director of this corporation is a party in any way connected with such person, firm or corporation and every person who may become a director of this corporation is hereby relieved from any liability that might otherwise exist from contracting with the corporation for the benefit of himself or any firm, association, or corporation in which he may be in any way interested.

ARTICLE 9 - REMOVAL OF DIRECTORS

Any director of this corporation may be removed at any annual or special meeting of the shareholders by the same vote as that required to elect a director.

ARTICLE 10 - INDEMNIFICATION

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE 11 - AMENDMENT


