OF

ARTICLE II

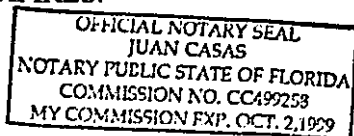


