ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

1.01. The name of the Corporation is **BLAKE & COMPANY, C.P.A.s, P.A.**

ARTICLE TWO

DURATION

2.01. The term of existence of the Corporation is perpetual.

ARTICLE THREE

PURPOSE

3.01. The purposes for which the Corporation is organized is to perform all such acts and supply all such services as are commonly performed or supplied by certified public accountants and bookkeepers, including, but not limited to, the examination, inspection, and audit of the books and accounts of others, the preparation of financial statements, the compilation of statistics as an aid to others in the making of reports and statements required by tax laws, and to do all things incidental and necessary to the accomplishment of the foregoing purposes.

ARTICLE FOUR

CAPITAL STOCK

4.01 The aggregate number of shares that the Corporation has authority to issue is 1000, all of which shall be common shares with par value of \$1.00.

ARTICLE FIVE
REGISTERED OFFICE

5.01. The street address of the initial registered office of the Corporation is 102 W. Whiting Street, Suite 600, Tampa, Florida 33602, and the name of the initial registered agent at that address is Charles C. Blake, III, his signature below reflecting his acceptance of the designation as registered agent.
