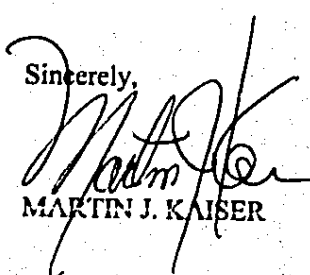

ARTICLE I. NAME

The name of this corporation is A.E.C. MANAGEMENT INC.

ARTICLE II. DURATION

The duration of this corporation shall be perpetual commencing on the date of execution or as soon thereafter as permitted by law.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of carrying on the business of business management and for the purpose of transacting any and all lawful business.

ARTICLE IV. S CORPORATION

The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than thirty-five persons. 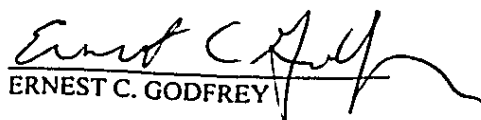
ARTICLE IX. BYLAWS
