ARTICLES OF INCORPORATION

OF

HOFFCO MARKETING, INC.

THE undersigned hereby adopts the following Articles for the purpose of forming a corporation under the following in the Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I

The name of the corporation is HOFFCO MARKETING, INC.

ARTICLE II

The corporation is to commence its existence on the date of filing and acknowledgement of these Articles of Incorporation and shall exist perpetually thereafter until dissolved according to law.
