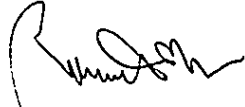

ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of Surfside Anesthesia Services, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. Name

The name of the corporation is:

ARTICLE II. Mailing Address

ARTICLE III. Commencement of Existence

The existence of the corporation will commence on the filing of these Articles of Incorporation.

ARTICLE IV. Purpose

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. Authorized Shares

The maximum number of share that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE VI. Initial Registered Office and Agent

The street address of the initial registered office of the corporation is 2474 S.W. 27th Terrace, Miami, Florida 33133, and the name of the corporation's initial registered agent at that address is Robert M. Mayer.

ARTICLE VI. Initial Board of Directors

The corporation shall have one director initially. The number

of directors may be either increased or diminished from time to time, as provided by the bylaws, but shall never be less than one. The name and street addresses of the initial director is:

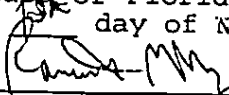
ARTICLE IX. Bylaws

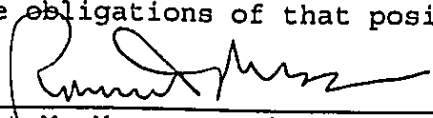
