### ARTICLES OF INCORPORATION

OF

### ACCURATE EVENT SERVICES, INC.

### ARTICLE I - NAME

The name of this corporation is ACCURATE EVENT SERVICES, INC.

#### **ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

### **ARTICLE III - PURPOSE**
