This corporation shall have all the powers enumerated on the Florida General Corporations Act.

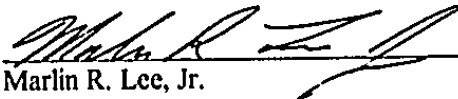
ARTICLE XI - INDEMNIFICATION

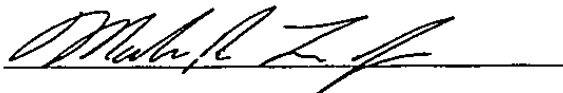
