

DEAN SCHARN, INC.**



Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned corporation adopts the following articles as amended to its Articles of Incorporation of Dean Scharn, Inc.:

1. The present name of the corporation is Dean Scharn, Inc.
2. The following amendment to the Articles of Incorporation adopted by the sole shareholder, and sole director of the corporation on February 22, 2000 in the manner prescribed by the Florida General Corporation Act; the name of the corporation shall be changed to D Roofing.com, Inc.
