**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION  
OF D ROOFING.COM, INC.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned corporation adopts the following articles as amended to its Articles of Incorporation of D Roofing.com, Inc.:

1. The present name of the corporation is D Roofing.com, Inc.
2. The following amendment to the Articles of Incorporation adopted by the sole shareholder and sole director of the corporation of February 22, 2001 in the manner described by the Florida General Corporation Act; the name of the corporation shall be changed to <sup>Dean</sup> Roofing of Florida, Inc.
