The undersigned Incorporators do hereby execute these Articles of Incorporation under the provisions of Chapter 607, Laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is ANTIQUE ARMOIRE, INC.

INDEMNIFICATION



This corporation accepts and adopts all powers of indemnification given by the provisions of Section 607.850 Florida Statutes, including provision for insurance.

AMENDMENT

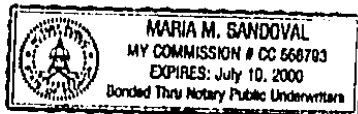


