ARTICLES OF INCORPORATION
OF
MID FLORIDA CONVEYORS, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby sets forth his intention to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is MID FLORIDA CONVEYORS, INC.

ARTICLE II

This corporation shall become effective December 1, 1996 and shall exist perpetually.

ARTICLE III

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE IV

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE V

The registered office of this corporation in the State of Florida is 8445 Florida Boys Ranch Road, Groveland, Florida 34736 The Registered agent for this corporation at this address is TERRY W. ZEIGLER. The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE VI


