ARTICLES OF INCORPORATION

<u>OF</u>

JOHN'S ACCOUNTING, INC.



The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME OF CORPORATION

The name of this corporation is: JOHN'S ACCOUNTING, INC.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

PURPOSE OF BUSINESS

The purpose of this corporation is to engage in the transaction of any and all business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

PRINCIPAL PLACE OF BUSINESS

The address of the principal place of business of this corporation is: 745-D 12th Avenue South, Naples, FL 34102.

ARTICLE V

REGISTERED OFFICE

The address of the initial registered office of the corporation

is: 745 12th Avenue South, Naples, FL 34102.

The Board of Directors may from time to time move the registered office to any other address in Florida.

ARTICLE VI

REGISTERED AGENT

The registered agent of the corporation for accepting service of process pursuant to Section 48.091, Florida Statutes, shall be John C. Joanides, 745-D12th Avenue South, Naples, FL 34102.

ARTICLE VII

DIRECTORS

This corporation shall have not less than one (1) director. The name and address of the initial director of this corporation is:

JOHN C. JOANIDES, 745-D12th Avenue South, Naples, FL 34102. The number of directors may be set from time to time by resolution adopted by a majority vote of the outstanding common shares.

ARTICLE VIII

CAPITAL STOCK

The maximum number of shares of stock in this corporation which is authorized to have outstanding at any one time is FIVE-HUNDRED (500) shares of Common Stock at \$1.00 par value. Each stockholder shall be entitled to one (1) vote for each share of stock.

ARTICLE XI

INCORPORATOR

ARTICLE X

AMENDMENT

These Articles of Incorporation may be amended, changed, repealed only by a majority vote of the outstanding common shares.


