## ARTICLES OF INCORPORATION OF PATRICIA SABERS, D.M.D., P.A.

The undersigned, for the purpose of forming a corporation under Chapter 621, Professional Service Act, does hereby adopt the following Articles of Incorporation:

<u>Article I. Name and Address</u>. The name and address of the Corporation is: Patricia Sabers, D.M.D., P.A., 755 S. Palm Avenue, Sarasota, Florida 34236.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purpose. The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way. The specific purpose of this association is that of a dentist.
