

The undersigned, acting as Incorporator of a corporation under the Florida Gérieral Corporation Act, adopts the following Articles of Incorporation for such corporation:

## ARTICLE I

The name of this corporation is Tucker/Mills Inc.

#### ARTICLE II DURATION
