The undersigned, acting as Incorporator of a corporation under the Florida Géneral Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I NAME

The name of this corporation is Tucker/Mills Inc.

This Corporation shall have perpetual existence unless dissolved according to law.
